Rules and Application

No alcoholic beverages allowed. No stringers or fish baskets allowed. Life preservers must be worn anytime the combustion engine is in operation. All PA Fish & Boat Commission rules apply. All committee decisions are final. Artificial lures only. No trolling. Must have an aerated live well. Contestants must remain in boat (with exception for emergency). Dead fish will be weighed (8 oz. Penalty) (lunker must be alive). All fish will be released. Only one rod per angler may be used, at any given time. 5 fish limit, any short fish will not be weighed, 1 lb. Penalty for short fish, 1 lb. Penalty for each minute late at check-in, 15 minutes late will be disqualified. Ties will be broken by: most legal fish, then most legal live fish. Launch will be at first safe light. Applications will be accepted the morning of tournaments (cash only) (no checks). 3 person teams (2 anglers + 1 alternate), alternate can be used for any event, anglers can only belong to one team. **NO EXTRA GAS CAN, UNLESS APPROVED BY FISH COMMISSION!** Must notify tournament officials, your team number, whether weighing Fish or not! If you trailer your boat for weigh-in, you must notify an official and find out where to park, be ready to weigh at 2:00pm not trailer at 2:00.

Use our bags only! 1st safe light to 2:00PM Meeting before start of each tournament. Please launch early!

COST: \$80 for River tournaments (includes lunker)
NO CHECKS

Optional lunker for year, \$20. Per team, heaviest smallmouth bass for the 5 tournament schedule will get 100% payback
